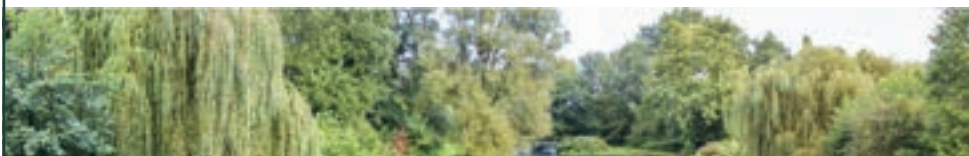

# NOTES FOR CATTLE & SHEEP EXHIBITORS 2025

Judging starts from 9:30am in cattle rings

These will run in accordance with DEFRA Guidelines at the time of the Show  
(which may be subject to change in the intervening period between the issue of the Schedule and Show day)

Entry fees: Cattle - Non Members £10.00, RAHSS Members £8.00 each

Sheep – Non Members £7.00, RAHSS Members £5.00 each

Closing Date for cattle and sheep entries is MONDAY 18TH AUGUST 2025

PLEASE NOTE: Entries are processed via software –  
Showing Scene and payment processed via Stripe (card payment).

**Late Entries** – Late entries will be accepted only at the discretion of the Show Secretary. Entries will be accepted on a first come basis.

**Substitution** – Substitution is allowed, as authorised in Show Regulations, **but only in the same class as that in which the original animal was entered.**

## Health & Safety

Cattle unloading bays will be in operation on Show morning and on Friday afternoon until 9pm.

The attention of all exhibitors is respectfully drawn to the DEFRA Code of Practice “The Welfare of Animals in Livestock markets”.

PLEASE NOTE: ‘Farm’ vehicle passes, for parking in the bio-security area, will ONLY be issued to cattle/sheep lorries or boxes and towing vehicle. Due to Health and Safety and limited parking, cars will be requested to park in the FREE PUBLIC CAR PARK.

Dogs are permitted in most areas at the Romsey Show, provided they are kept on non-retractable leads. However, we do not allow dogs in the cattle and sheep lines (except for assistance dogs) and request exhibitors to cooperate with this ruling.

**No gas appliances or generators are to be used within livestock animal areas or near forage and straw.**

## Grand Parade

The Rules & Regulations require that **ALL prize-winning cattle and sheep must take part in the Grand Parade, held at 3pm within the Cattle Area or risk forfeiture of prizes.** The committee would appreciate it if exhibitors would also parade non-prize winners. In the case of sheep, a decision will be made on Show Day as to whether it will be Non-MV Accredited sheep or MV Accredited sheep participating in the Grand Parade (due to enforceable accreditation regulations for the Show). Stewards reserve the right to remove any animal deemed unsafe from the Grand Parade. **Sheep/Cattle must not be loaded for removal until 4.30pm or prizes will be forfeited. If an exhibitor has cattle remaining in the cattle pens, they must have at least one person remain in the area with the animal(s).**

## Veterinary Cover

Although there will be no veterinary cover on the Showground until 7am on Show day, the telephone number of our out of hours honorary veterinary practice will be displayed in the cattle lines.

## Cattle and Sheep Lines

**Free penning for Cattle.** A plentiful supply of quality straw is available. There will be no marquee for cattle at the show, Exhibitors will be required to bring their own gazebos as cover. The public will be able to view stock as per DEFRA Guidelines. Exhibitors who prefer their animals to be screened are asked to bring their own headboards. Exhibitors bringing calves at foot should show this in the appropriate section on the online entry form so that adequate space may be allocated.

**PLEASE NOTE: ALL BOVINES (INCLUDING CALVES) THAT ATTEND SHOWS MUST HAVE A SINGLE SHEET PASSPORT (CPP52) OR CHEQUEBOOK-STYLE PASSPORT (CPP13).**

Sheep will have separate open-air unloading/loading bays, and separate penning for MV accredited and nonaccredited stock will be in operation on Show day. No cover is provided for sheep exhibitors.

## Refreshments

Hot and cold snacks and beverages will be available from 7.00am on Show day from around the showground. A catering unit will be available on the Friday in the centre of the show ground from lunchtime until tea time.

## Cattle/Sheep Stockpersons

A free Stockmen’s Breakfast and drink will be available for stockpersons with a ratio of 1 breakfast for up to every 4 animals exhibited. Breakfast tickets will be given out to cattle stockpersons when passports are checked (additional tickets may be purchased with cash). Sheep exhibitors’ tickets will be given out by the Chief Sheep steward (additional tickets may be purchased with cash).

## Prize Money

Exhibitors will be paid after the Show via BACS, no prize money cash will be provided on the day. Exhibitors will need to include their bank details on their entry to ensure they are able to receive prize money post-show. The prize money will be paid up to one month after the Show. Showmanship and Young Handler classes will have prize money paid to the owner of the animal as per the entry form, not the handler. It is therefore the responsibility of the entrant to distribute any prize monies to the placed young person.

## Cups/Shields

From 2025, exhibitors will be required to pay a deposit of £100 (per exhibitor) should they wish to take their cup/shield home. The deposit will be returned by the Show Society once all the cups/shields under that exhibitor’s name have been returned undamaged and in good condition the following year, as requested by the Society. Exhibitors will be required to present their ID (driving licence/passport) at the Secretary’s Tent in order to be issued with the cup/shield on show day. The details written on the cup card must match the ID. No cups/shields will be allowed to leave the site if the exhibitor does not have proof of ID.

Exhibitors are liable for the payment of the replacement cup (s) value as per the official Society’s insurance valuation should they not return the cup/shield by the requested date on the form. Deposit payments will be returned via bank transfer within one month of the cup being returned.

## Entry Tickets

Exhibitor Admission to this year’s show will be via Exhibitor Wristbands, which will be provided based on total entry fees paid and posted before the show.

1 animal entered - 2 Wristband passes

2 animals entered - 3 Wristband passes

3 animals entered - 4 Wristband passes.

Thereafter 1 pass per animal up to a maximum of 6 Wristband passes

**Additional tickets or wristbands may be purchased at a rate of £18.00 each, with your entry. After this date they will be available at the show price listed online.**

## CATTLE NOTES:

1. All cattle classes are open unless otherwise stated.
2. All cattle must be halter led.
3. Bulls must be shown in accordance with Guidance Note GS 36 issued by the Health and Safety Executive.
4. The Society reserves the right to restrict the numbers of entries in accordance with the available penning facilities.
5. Substitutions will be accepted on Show day up to 8.00am provided they are notified in writing to the Secretary or Chief Cattle Steward, but only in the same class as that in which the original exhibit was entered.
6. Exhibitors may only enter an animal in one section.

## Conditions: Bovine TB and Pre-Movement Testing

ALL cattle must be from herds on which no movement restrictions have been served by DEFRA. No animal accepted for entry may be exhibited if, after entry, such movement controls are imposed.

These rules will apply to all cattle, not just ‘High risk’ herds. It is The Show’s policy that all bovines are pre-movement TB tested moving from premises in any parish within 60 days of the show. Herds where TB tests are scheduled at an interval of 4 years will still require pre-movement testing, in adherence of The Show’s policy.

In the event of these regulations changing, exhibitors should be aware and must comply with the current legislation, rules and conditions in force at the time of the Show.

**Exhibitors will be required to provide written confirmation of these test results with their entry and MUST also have them available for inspection on Showday.**



## DEFRA AND CATTLE HEALTH 2001 SCHEME

Legal requirements for the Movement of Animals/Cattle Passports

Show holding Number: 15/269/8104

Exhibitors are reminded to ensure that they, or their haulier, can provide upon request, completed Animal Transport Certificates, for the journey(s) to the Showground.

Any animal that attends the show must be accompanied by a **chequebook-style or single sheet passport**.

Guidance on the necessary completion of Cattle Passports to/from Showgrounds can be obtained from the BCMS Helpline, telephone 0845 050 1234.

Owners of all stock are reminded that the relevant records of the animal(s) movements to the Show must be duly entered into their On-Farm Register or movement book within 36 hours.

## ALL BREEDS DAIRY CATTLE

Entry Fee: Non-Members £10.00. Members £8.00 each entry

ENTRIES CLOSE: Monday 18<sup>th</sup> AUGUST 2025

Judging commences at 9.30am. All cattle must be penned by 8.00 a.m.

Open to animals of any dairy breed or cross breed.

Please visit the Schedule page of the website for the appropriate information. Applications should be made online via our Showing Scene software, including the payment (done via Stripe).

**EXHIBITORS PLEASE NOTE** – There will be no cattle marquee, you will need to bring your own cover for the pens.

In all classes where 'special prizes' are available, BEST HOLSTEIN is defined as an animal SIREd by a Holstein bull, BEST JERSEY is defined as an animal SIREd by a Jersey bull, and BEST OTHER BREED is defined as an animal SIREd by a bull of any breed other than a Holstein or a Jersey (for example, it could be sired by a Friesian).

If insufficient entries are forward, the Society reserves the right to amalgamate dairy classes as it sees fit, at the discretion of the Chief/Senior cattle steward.

All calves being shown must be under 12 months of age in the Junior Class (Class 117). For all other classes, the animal must be under 24 months of age.

EACH CALF SHOWN IN THE DAIRY SHOWMANSHIP JUNIOR, INTERMEDIATE AND SENIOR CLASSES MAY ONLY BE UTILISED IN ONE OF THESE THREE.

Exhibitors may only enter Classes 117 to 119 with animals which have previously been entered and shown in another class within the dairy section.

THE VETERAN HANDLER CLASS WILL NOT CONTRIBUTE TO THE CHAMPIONSHIP. ANIMALS THAT HAVE BEEN USED IN THE JUNIOR, INTERMEDIATE OR SENIOR CLASS MAY BE USED IN THE VETERAN HANDLER CLASS.

LATE ENTRIES WILL BE PERMITTED.

ONLY COMPETITORS MAY LEAD THE CALVES IN THESE SHOWMANSHIP CLASSES – NO ASSISTANCE WILL BE ALLOWED.

# RULES & REGULATIONS – for Exhibitors

**The Council will not be responsible for any error, which may appear in the catalogue, or for any entry being made in the wrong class. It is the responsibility of each exhibitor to read these rules and abide by them.**

The Show Society takes the health and welfare of animals seriously. The Show Society will take whatever appropriate measures it deems necessary to ensure the best welfare conditions exist for all animals. All exhibitors are required to ensure their animals are fit and healthy upon arrival and throughout their time at the Show. More details relating to health and welfare matters can be found elsewhere in these Regulations. The Society has a vet on site for show day and their decision on animal welfare matters is final.

1. The printed/online entry forms and certificates to be filled in by exhibitors for prizes at the Annual Show shall be kept by the Secretary and every person intending to exhibit shall enter online (or via post if online is not possible) and pay the appropriate entry fee by the date advertised in the Schedule. No prize shall be awarded unless the exhibitor shall have first complied with this rule. Any entry received after the date above referred to shall be accepted only at the discretion of the Secretary and any such late entry that may be so accepted shall be liable to an entry double the normal entry fee [no exceptions].

2. Any exhibitor or other person deceiving or attempting to deceive the Council by entering animals in the wrong classes, ownership or name contrary to these Rules, Classes and Regulations will forfeit the whole of the entrance fee, or any other prizes won by him/her at the Show except prizes won by exhibits correctly entered by him/her and will not be allowed in future to exhibit at the Romsey Agricultural and Horse Show Society's exhibitions. The responsibility for correctness of all entries will rest with the owner or his/her agent and not with the Secretary of the Society for accepting such entry.

3. Any exhibitor, or other person, deceiving the Council by entering animals which have been administered any medicament or drug thereby hiding their true mental or physical condition, will forfeit their entrance fees and any prizes won and will not be allowed to exhibit in the future. The Society reserves the right to test any horse or livestock exhibits for the presence of hormones or illegal substances, which may affect the behaviour, or performance of the animal in the ring. Refusal to submit a sample will be dealt with by the Society at their discretion.

4. The Society vet will have the right to treat an animal if urgent attention is required and the owner cannot be found. Owners are however not

permitted to leave animals unattended for the duration of their time at the Show.

5. Unless otherwise stated, exhibitors may enter an unlimited number of animals in each class, subject to the special conditions of the respective classes.

6. Every exhibitor of livestock who shall send for exhibition any animal which, to his/her knowledge is not safe to handle, or is suffering from, or has been in contact with any animal suffering from any contagious or infectious disease, shall forfeit and pay to the Secretary the sum of £1,000 as and for liquidated damages for each and every animal sent, and in the event of the Society's Veterinary Inspector certifying that any animal sent for exhibition is, in his/her opinion, a source of danger, such animal shall be removed with due speed by the exhibitor or his servant from the Showground, or be otherwise dealt with as the Veterinary Inspector may direct with a view to averting danger or the spread of contagion.

7. **ALL prize-winning cattle and sheep must take part in the Grand Parade, held at 3pm in the Cattle Rings or risk forfeiture of prizes.** The committee would appreciate it if exhibitors would also parade non-prize winners. In the case of sheep, a decision will be made on Show day as to whether it will be Non-MV Accredited sheep or MV Accredited sheep participating in the Grand Parade (due to enforceable accreditation regulations for the Show). Stewards reserve the right to remove any animal deemed unsafe from the Grand Parade. **Cattle must not be loaded for removal until 4pm or prizes will be forfeited.** Cattle may be paraded in order of breeds and classes as shown in the schedule. At the discretion of the Grand Parade Chief Steward.

No cattle exhibits are to be removed before **4.30pm**. The Secretary has no authority to give any written or verbal permission for an exhibit to be removed. The Council reserves the right to reject any exhibit or exhibits not complying with this regulation.

8. In cases where the prizes are offered or awarded conditionally, and in the classes for novices, they will be withheld until the exhibitor shall have proved to the satisfaction of the Council that the conditions have been complied with, and it is incumbent that the exhibitors prove the correctness of their certificates if required to do so. Should any exhibitor fail to do so to the satisfaction of the Council, the entry in question will be disqualified and awards made to it will be cancelled.

9. In cases of any prize animals being disqualified, the winner of the next succeeding prize in that class shall take the prize that has been awarded to such disqualified animal. The lowest prize in the class shall go to the reserve number provided a reserve ticket has been awarded.

10. Any exhibitor or his/her servant who shall refuse to obey an order from the stewards or who shall be guilty of improper behaviour shall not be allowed to compete, and the Council shall have the power to order the offender to leave the Show and to refuse that person's entry for future Shows. The Council reserve the right to reject or cancel the entry or entries made by any person, if they deem it fit to do so.

11. Numbers will be supplied by the Secretary, and must be properly attached to each exhibit by the exhibitor before being admitted to the Show ring. No exhibit will be allowed to wear rosettes or ribbons other than those issued by the Society.

12. All stock and servants in charge of same will be subject to the Orders, Rules and Regulations of the Society. Servants only will be allowed to enter the Showground with stock.

13. No animal may be permitted to be removed from its place without the permission of the Stewards of the department.

14. No person shall be allowed to fix any placard on the Showground without the written permission of the Secretary, and no exhibitor shall be allowed to distribute handbills on the Showground.

15. A free admission wristband/badge will be sent to each exhibitor, and wristbands/badges for use of bona fide servants in charge of stock. In case of the transfer or the improper use of a wristband/badge, it will immediately be cancelled and the full price of admission charged.

16. No person but the ring stewards and any authorised official shall be in any of the rings, or shall have any communication with the judges during the time judging is taking place. Any exhibitor or their agents acting in opposition to this rule shall forfeit such premiums as may be awarded to their exhibit. No exhibits to enter the rings with any distinguishing mark save as allowed by the Regulations.

17. In cattle classes, second and third prizes will always be awarded unless the judge considers the entries of insufficient merit. Should there be any recommendations not recorded in the schedule such recommendations will be decided upon at Council subsequent to the Show, but the recommendation shall not in any way bind the Council to award the prize.

18. No prize shall be awarded when, in the opinion of the judges, there is not sufficient merit, and neither shall any premium be given to the exhibitor who shall not have complied with the Regulations of the Society.

**19. Every animal must be paraded (including in the Grand Parade), or ridden or driven as and when required by the Council; any exhibitor failing to comply with this Regulation shall pay a forfeit of £10 or their prize money.**

20. All animals must be brought properly secure to the satisfaction of the stewards of the department, or they will not be admitted to the ground. The animals will be paraded in the ring at the discretion of the steward and exhibitors are requested to see that sufficient staff are in attendance for this purpose at the hours appointed by the stewards.

**21. BULLS MUST BE SHOWN IN ACCORDANCE WITH GUIDANCE NOTE GS36 ISSUED BY THE HEALTH AND SAFETY EXECUTIVE.**

22. Every animal will be considered and treated as being in the sole custody of the exhibitor during the whole period of the Show, and until removed every exhibitor must have at least one servant in charge of the animals exhibited by him/her, and the Romsey Agricultural and Horse Show Society will not be responsible in respect of any loss, damage or injury arising from accident or any other cause whatsoever. The servant in charge must have the admission or delivery order in his possession.

23. Any exhibitor lodging any objection must deposit £50, which will be forfeited if the objection is disallowed; all objections must be delivered in writing at the Secretary's office on the Showground within 30 minutes of the incident, which has caused the objection to be raised. The Council whose decision shall be final will decide upon the objection.

24. All disputes respecting the Rules and Regulations of the Society together with all questions, the consideration of which is not otherwise provided for, shall be referred to the Council, whose decision shall be final.

25. All exhibits must be ready 10 minutes prior to the start of the class and must be present in the ring to be judged.

26. **ALL PRIZE MONEY will be paid via BACS from the Show Office within one month after the show. No prize money will be available on show day. In order for Exhibitors to receive their prize money they must include payment details on their online entry form. Cattle exhibitors not entering the Grand Parade at 3.30pm, or loading their animals before 4.00pm, risk forfeiting their prize money.**

27. **Cups/Shields** -From 2025, exhibitors will be required to pay a deposit of £100 (per exhibitor) should they wish to take their cup/shield home. The deposit will be returned by the Show Society once all the cups/shields under that exhibitor's name have been returned undamaged and in good condition the following year, as requested by the Society.

Exhibitors will be required to present their ID (driving licence/passport) at the Secretary's Tent in order to be issued with the cup/shield on show day. The details written on the cup card must match the ID. No cups/shields will be allowed to leave the site if the exhibitor does not have proof of ID.

Exhibitors are liable for the payment of the replacement cup (s) value as per the official Society's insurance valuation should they not return the cup/shield by the requested date on the form. Deposit payments will be returned via bank transfer within one month of the cup being returned.

28. Entries may be substituted provided the information is given to the cattle Steward upon arrival.

29. Entrance fees for livestock exhibits, which have to be withdrawn before the Annual Show due to illness or accident will be refunded, provided a Veterinary Officer's Certificate is produced, within one month of the show.

30. Every exhibit must be the bona fide property or leasee of the exhibitor at the time of entry except in the case of the Heavy Horse Turnout where the owner of the vehicle shall be considered as the exhibitor. If the animal is sold after the date of entry the change of ownership must be noted to the Show Secretary. Stallions leased for the season will be considered the property of the lessor.

31. The term exhibitor will include persons taking part in any competition or display arranged by the Society, and the owner of any animal, plant, machinery, or other thing involved in such competition or display otherwise exhibited in the Showground. Save for death or personal injury caused by negligence of the Society, its servants or agents, the Society will not be responsible for death, injury, disease, damage or loss caused to an exhibit or to their servant or agent or to any animal, article, plant, machinery, or thing of whatever nature brought to the Showground by said exhibitor from whatever cause such as death, injury, disease damage or loss arises.

32. The Society shall not be responsible to any person whosoever whilst upon the Society Showground for any form of economic loss whether direct or indirect how so ever caused.

33. The Society requires all Entrants and Exhibitors to insure themselves and their exhibits against all liabilities both to the Society and to all other persons using the Society Showground unless the Secretary has given written dispensation. The right is reserved to require an appropriate certificate of insurance to be produced for inspection by the Society at the Show Office or upon the Showground.

34. All entrants shall indemnify and hold harmless the Society from and against all actions, suits, expenses and claims made against the Society on account of or in respect of the negligence or breach of contract of the entrant.

35. The Society reserves the right to print exhibitor details in the Show Catalogue and the results. Completion of the entry form indicates that the exhibitor has agreed to these arrangements.

36. The use of mobile phones is NOT permitted if a competitor, exhibitor and/or their associates are responsible for an animal (ie holding, leading, or riding) in the cattle or horse walks, exercise area, warm up areas, and collecting rings. The use of mobile phones in the judging rings is forbidden. Mobile phones must NOT be used when handling animals in the Grand Parades. Any person found using a mobile phone when handling an animal or supervising a young person handling an animal will be excluded from the ring or parade.

37. **POSTPONEMENT/CANCELLATION OR ABANDONMENT. Exhibitors shall not have any claim against the Society or any member of the Society in respect of any loss or damage whatsoever consequent upon the show or any part of it failing to be held or having to be abandoned (for whatever reason eg extreme weather, security alerts, etc). No entry monies will be repaid and the Show Society will have no liability for expenses, consequential loss or damage suffered by exhibitors or their representatives as a result of this action.**

38. Any artificial contrivance or device of any description found on or proved to have been used on an animal at any time whilst that animal is in the Showground, either for preventing the flow of milk or for any other improper purpose, will disqualify that animal from being awarded a prize, and any prize awarded prior to discovery will be forfeited. The Instigator or The Owner of the said animal may be prohibited from again entering Stock for any of the Society's Shows, for such period as the Committee may see fit. For the purpose of this

Regulation, the term 'improper practice' shall be held to include setting of teats, and generally any other practice including tampering of their own or any other animal by the exhibitor or any other person which results in the animals being shown other than in a natural state, and the Society reserves the right to have all animals inspected by the Society's Veterinary Officers, prior to, during, or after judging.

The Society will not tolerate the administration to show exhibits (entered either for competition or sale/demonstration) of tranquillisers or other drugs which may in any way affect the performance of the animal in question to have the effect of making it behave in the show ring in a manner which is not natural. The Society reserves the right to take any necessary samples. Any Person or Exhibitor (or his/her representative) who is found to have administered or permitted the administration of any such tranquilliser or drugs to any Show exhibit will be reported to the Organising Committee, and dealt with at their discretion. In addition the matter will be referred to the appropriate Breed Society or Organisation.

Any Exhibitor wishing to lodge an objection, having reference to Livestock exhibited at this Show, must make the same in accordance with the objection requirements of the Society. If, on investigation, the objection is not sustained to the satisfaction of the Committee, the sum thus deposited shall, at the discretion of the Committee, be forfeited to the funds of the Society. All objections must be lodged on the same day as the alleged incident occurred in accordance with the objection regulations, and no objection will be SUBSEQUENTLY received, unless a reason, satisfactory to the Committee be assigned for the delay.

39. **BOVINE TB and PRE-MOVEMENT TESTING**

**ALL cattle must be from herds on which no movement restrictions have been served by DEFRA. No animal accepted for entry may be exhibited if, after entry, such movement controls are imposed.**

Please refer to <http://www.defra.gov.uk/animal-diseases/a-z/bovine-tb> and <http://www.defra.gov.uk/animal-diseases/a-z/bovine-tb/publications> for further information. These rules will apply to all cattle, not just 'High risk' herds. It is The Show's policy that all bovines are pre-movement TB tested moving from premises in any parish within 60 days of the show. Herds where TB tests are scheduled at an interval of 4 years will still require pre-movement testing, in adherence of The Show's policy.

Any/ALL alpacas must be pre-movement tested for Bovine TB and from flocks on which no movement restrictions have been served by DEFRA. No animal accepted for entry may be exhibited if, after entry, such movement controls are imposed.

**ALL exhibitors (cattle) will be required to provide written confirmation of these test results with their entry, and also have them available for inspection on Showday.**

In the event of these regulations changing, exhibitors should be aware and must comply with the current legislation, rules and conditions in force at the time of the Show.

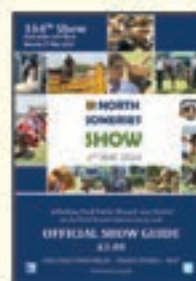
